- · You acknowledge that this agreement takes effect at the time of your signing this enrolment form.
- Your place in a class is only guaranteed with a completed enrolment form signed by your Parent/Guardian and your VET Coordinator.
- · VET students have the option of parents paying for the course, or the C.C.P. invoicing the student's school
- The balance of any fees paid will not be refunded after the term census date and you are liable for the full payment of the course. Please refer to the current schedule and note the term census dates.
- It is a policy of the CCP that in the case of a student withdrawing from a course after the 'term census date', refunds will not be made and the student is liable for any outstanding tuition fees for any classes enrolled.
- If for any reason a class in which you have enrolled cannot be conducted as scheduled, you will be notified. If there are no other suitable classes offered, then any fees and deposits that have been paid for that class will be refunded.
- In the event of any VET student withdrawing from any subject after the Term Census Date and within the first two weeks of the course commencement, the subject may be transferable to another VET student for a later term after full payment has been received by the C.C.P.
- · If fee by installment has been negotiated with the C.C.P., this will incur an extra \$40.00 administration charge.
- Fee by installment is only available for one class per term.
- The C.C.P. reserves the right not to allow fee by installment.
- Refunds will not be given for any absenteeism in a class. You are most welcome to complete a missed session at a later time within the year however; this session should be attended within one calendar year of commencement and only if that class runs during that time.
- · In the event of a suitable class not being offered at a later time, you are also welcome to transfer the pro-rated "refund" to facility use.
- Upon your successful completion of the course/s, you will be given a statement of attainment; statements of attainment will not be given to anyone with outstanding fees/debts.
- You agree to the C.C.P.'s extended Darkroom and Studio use policy.
- You acknowledge the C.C.P.'s Mission Statement.
- While attending the C.C.P., you agree at all times to use the equipment knowledgably, safely and responsibly, and to clean up your space before you leave.
